The Edina City Council awarded the proposed utility and roadway construction project in your neighborhood to Midwest Asphalt Corporation. You may have noticed some construction staking and road construction signs already on site. This work is in preparation of the anticipated May 19 start date.

Initial work will involve stripping topsoil in boulevard areas; replacement of fire hydrants and sanitary sewer spot repairs. Hydrant replacement will require temporary water shut offs. The contractor will give you 48 hours advanced notice.

Utility repairs/replacements scheduled to occur during this project include repairing the sanitary sewer mainline in various locations, draintile installation in boulevard areas to accommodate sump pumps (if present), storm sewer installation, and water hydrant replacement. The Contractor will be notifying you one to three days in advance of the water hydrant replacement work on your block. During construction, you may encounter stakes in your boulevard area. Please do not remove these stakes, the Contractor utilizes them to determine where and how to install utilities.

**Additional utility company repairs/replacements have already begun or, are scheduled to begin shortly. These include CenterPoint Energy. I would like to iterate that these are privately owned companies and have nothing to do with the City's project.**

Please recall that to better communicate the overall happenings of the project, the City recently introduced the City Extra e-mail notification service. This service is free and allows individuals to sign up to receive e-mail messages from the City on a variety of topics. City staff will update the City Extra e-mail notification system on a weekly basis for this project. These updates will be brief but will cover the weekly street reconstruction highlights. All residents, including those signed up for the e-mail notification system, will continue to receive paper copies of the construction update letters by US-mail informing you of the project's progress on about a monthly basis.
